
## **TEN PRINCIPLES OF ARYA SAMAJ**

### INTRODUCTION

DMC&H extends a warm welcome to the students entering the new academic year. We hope that the unique learning experience and ambience at DMC&H will unlock potentials and help you to achieve your dreams. We wish you the very best.

A devoted personality, Dr. Banarsi Dass Soni, Ex Capt. I.M.S., with a missionary zeal for medical education and patient care, conceived the noble idea of providing the much-needed medical care to the general public.

This bloomed in the form of Arya Medical School in 1934. It was started in a rented building in Civil Lines, Ludhiana and admission was limited to only 20 students.

The Medical School was recognized for Licentiate of State Medical Faculty (LSMF) in 1938 and also for the running hospital attached to it. The following year, the Managing Body decided that the Ludhiana Medical School should, in future, be called "Arya Medical School" and the hospital attached to it "Dayanand Hospital".

In 1964, consistent with the policy of the Government, Arya Medical School flowered into a full-fledged MBBS College, which came to be known as "Dayanand Medical College". The management of this college was taken over by a galaxy of prominent people of Ludhiana, who formed an organization known as the "Managing Society of Dayanand Medical College & Hospital, Ludhiana", and Late Shri H.R. Dhanda, a prominent industrialist of the town, became its Founder-President.

The college has come a long way, retaining its unique character, still marching ahead with the times and is upgrading itself dynamically in all its fields of activities. The institution has been rated among the top 15th medical colleges of the country and has been declared by CII Lombard to be among the top 10 multi-speciality hospitals in the country.

In the year 2006, DMC&H reached a new dimension with the introduction of superspeciality courses in Cardiology, Gastroenterology and Plastic Surgery first in the state. Today, besides running MBBS and MD/MS courses in 19 specialties, the institution offers 4 diploma courses, 8 DMC/MCh and 23 B.SC./Diploma Paramedical Courses.

Hero DMC Heart Institute, a unit of DMC&H is a renowned centre for tertiary level cardiac care providing all types of interventional and surgical procedures did large number of cognitional cardiac default surgery under NHRM.

Since its inception, the institution has produced about 4000 graduates and 220 post graduates. The students and faculty have constantly strived for academic excellence, state-of-the-art health care provision, and high quality research competing with the best in the country. All the departments of the hospital are equipped with modern facilities to provide tertiary level health care services to the people of the region.

DMC&H College of Nursing is one of the most modern equipped nursing colleges in Punjab. It is widely recognized as center of excellence in the field of Nursing Education with excellent job training facilities in North Zone. The College is affiliated to Baba Farid University of Health Sciences, Faridkot, recognized by Indian Nursing Council, New Delhi, Punjab Nurses Registration Council, Mohali and is approved by Punjab Govt.

The School of Nursing was started in 1954 with an idea to train Auxiliary Nurse Midwives. In 1969; the school was upgraded to 3 years General Nursing Course. School of Nursing is affiliated to the Punjab Nurses Registration Council, Chandigarh and is recognized by the Indian Nursing Council, New Delhi. It admits 50 students to the General Nursing & Midwifery (GNM) course every year. GNM course has been phased out in 2008 and specialized nursing courses were added.

The College of Nursing came into existence in October 2002. It admits 100 students in B.Sc. Nursing Course and 30 students in Post Basic B.Sc. Nursing course every year. However, Post Basic B.Sc. Nursing course was phased out in 2011. In addition institute has started Master of Sciences in nursing in 2010 with five specialties Psychiatric Nursing (5), Pediatric Nursing (2), Community Health Nursing (6), Obstetrical Nursing (6) and Medical Surgical Nursing (6). In 2017, Nurse Practitioner course in critical care was started with annual intake of 10 students.

DMC&H College of Nursing is now shifted to new campus at Malakpur, Hambran road, Ludhiana. The institution has a highly qualified and experienced faculty, many of whom have received national and international recognition for their research and publications. There are frequent visits of guest lecturers from national and international universities, which bring their research and development into classrooms.

The College has well-equipped laboratories of Nursing Foundation, Nutrition, Maternal and Child Health Nursing, Community Health Nursing, Anatomy, A.V Aids with latest equipments i.e. bandaging simulators, injectable simulator, I/V arms, breast examination model, manual labour manikin, adult and baby CPR simulators—and instruments. Laboratories of Anatomy, Physiology, Pathology and Microbiology of Medical College are also used for B.Sc. Nursing Students. College has computer lab with internet facilities.

There is a well-equipped separate library for nursing students with all the modern facilities like CBSCO app. The library has approximately 5358 nursing books. 18 national and international nursing journals as well as E-journal are subscribed yearly. In addition, there is main Library in the hospital, which is equipped with a large number of professional books and journals.

The College has air conditioned classrooms with modern facilities. To enhance the presentation of academic exercises like lectures, seminars etc., the institute has a good Audio-visual setup with L.C.D. projector, overhead projector, slide projector, TV, Interactive Panel, Sound system, models and charts for the use of the faculty and students.

A continuous emphasis on modern teaching methods, global links for research, world class infrastructure, placement, diversity of students and institute interactions have consistently placed DMC&H college of nursing students well ahead in every field,

The college possesses good and comfortable accommodation for girls with all the facilities including round-theclock security, entertainment, boarding and mess. Hostel rooms have attached bathrooms and geysers. Safe drinking water is available for students. Hostel has green pasture lawns, sports courts i.e. badminton, basketball, volley ball, and kho-kho as well as Gym and beauty salon.

### M.Sc. NURSING COURSE

#### **DURATION**

The duration of the course for the degree of Master of Sciences in Nursing shall be of two Academic years and the examination shall be divided into two years. The examination for first year and second year ordinarily will be held in May/June as per dates fixed by the University.

#### **ELIGIBILITY FOR PMNET-2024**

Eligibility will be as per the Prospectus of Punjab Master of Sciences (Nursing) Entrance Test – 2024 (PMNET-2024) issued by Baba Farid University of Health Sciences, Faridkot as per Government Notification No. 5/7/2013-5HB-III/5416 dated 09/09/2020.

#### **COURSES OFFERED**

The courses for degree of Master of Science in Nursing have five clinical specialties and a candidate shall opt for one of these:

i) Mental Health (Psychiatric) Nursing - 5 seats
 ii) Child Health (Paediatric) Nursing - 2 seats
 iii) Community Health Nursing - 6 seats
 iv) Obstetric & Gynaecological Nursing - 6 seats
 v) Medical Surgical Nursing - 6 seats

Medical Surgical Nursing has further two super- specialties:

Critical Care Nursing (3 seats)Cardio Vascular & Thoracic Nursing (3 seats)

#### **ELIGIBILITY CRITERIA/ADMISSION REQUIREMENTS**

- 1. The candidate should be a Registered Nurse and Registered Midwife or equivalent with any State Nursing Registration Council.
- 2. Minimum Education required: The candidate must have passed B.Sc. Nursing / B.Sc. Hons. Nursing / Post Basic B.Sc. Nursing from any institution which is recognized by Indian Nursing Council with minimum of 55% aggregate marks. For SC/ST candidates 5% relaxation of marks may be given.
- 3. Minimum Experience required: Minimum one year of work experience (clinical or teaching) after Basic B.Sc. Nursing or prior/ after Post Basic B.Sc. Nursing is required, preferably in any critical care setting prior to enrollment.
- 4. Any other qualification/ eligibility fixed by the university.
- 5. Candidate shall be medically fit.

#### **SELECTION PROCEDURE**

Selection of the candidates is strictly based on the merit of the entrance examination held by the University. For details see Baba Farid University of Health Sciences website i.e. <a href="www.bfuhs.ac.in">www.bfuhs.ac.in</a>.

#### **EXAMINATION**

- Student who will remain on the rolls of the college and fulfil the following criteria signed by the Principal of the College will be allowed to sit in the examination:
  - a) Satisfactory record of professional work and conduct
  - b) Not less than 80% attendance in theory and in practical. However 100% of attendance for practical before the award of degree.
- The medium of examination shall be English
- He/She shall submit his/her thesis plan so as to reach the Registrar end of the 9 months from the date of his/her admission. The thesis shall be submitted in the University 3 months before the commencement of the theory examination i.e. 31<sup>st</sup> May of the preceding year of examination.
- There shall be internal assessment for which marks shall be reserved as follows:

Theory papers - 25 % each
Practical - 50 % each

Thesis - 50 %

#### MINIMUM PASS MARKS/ PROMOTION

- Minimum pass marks shall be 50% in each of the Theory and Practical papers separately.
- A candidate must have minimum of 80% attendance (irrespective of the kind of absence) in theory and practical in each subject for appearing for examination.
- A candidate must have 100 % attendance in each of the practical areas before award of degree.
- A candidate has to pass in theory and practical exam separately in each of the paper.
- If a candidate fails in either theory or practical paper he/she has to re-appear for both the papers (Theory and practical).
- Maximum no. of attempts permitted for each paper is 3 including first attempt.
- The maximum period to complete the course successfully should not exceed 4 (four) years.
- A candidate failing in any subject of 1st year shall be promoted to the IInd year.
- No candidate shall be admitted to the subsequent 2<sup>nd</sup> year examination unless the candidate has passed the I<sup>st</sup> year examination.

#### **CLASSIFICATION OF RESULTS**

Successful candidates shall be classified as under on the aggregate marks obtained in first year and second year examination taken together.

a) Those who obtain 60 percent or more of total marks

of 1<sup>st</sup> and 2<sup>nd</sup> year examination

## **B.Sc. NURSING COURSE**

Each year 100 students are admitted to the college.

For admission to Private/ State/ University Institutes of Nursing, against Foreign Indian Students (NRI) seats as per provision of "The Punjab Private Health Sciences Educational Institutional (Regulation of Admission Fixation of Fee and making of Reservation) Act,2006" as amended from time to time.
- **Preference** For admission to the seats reserved for the Foreign Indian Students (N.R.I.). candidates preference is given as follows:
  - a) First preference will be given to those Foreign Indian Student (N.R.I.) candidates who are having ancestral Punjab resident background.
  - b) Second preference will be given to those Foreign Indian Students (N.R.I.) candidates who are having ancestral backgrounds of other states of India other than Punjab.

The semester examination shall ordinarily be held in the month of May/June on dates fixed by the University. To appear for the semester examination, following conditions must be fulfilled. For that candidate must:

- i) has been on the college roll for one academic year preceding the examination.
- ii) has a good moral character as certified by the Principal
- iii) has attended not less than 80 percent of lectures and practical held in each subject and 80 percent of clinical practical in nursing subjects in which she wishes to be examined. A candidate must have 100% of attendance in each practical area before the award of degree.
- iv) should be medically fit.

#### INTERNAL ASSESSMENT

- I. Internal assessment marks in each subject shall be reserved as under:
  - a) each theory paper 25 percent marks
  - b) each practical 50 percent marks
- II. If a candidate fails in any subject(s) in the university examination, she/he will be reassessed for the same subject(s) for subsequent examinations and her/his reassessed internal assessment to be sent to the University.
- III. The practical work done by each student during the semester/year shall be recorded in a notebook, which must be attested by a Professor in-charge of the subject concerned and presented to the examiners at the time of practical examination. In case of absence of Professor in-charge, a Reader in-charge, a Lecturer in-charge or a teacher in-charge may attest the practical record notebook with the consent of the Principal of the college.

IV. Internal assessment in each subject shall be allotted on day-to-day class work and periodic class examinations, both written and practical.

#### **MINIMUM PASS MARKS & PROMOTION**

- I. Minimum pass marks shall be 40% (P grade/4 point) for English only and elective modules.
- II. Minimum pass marks shall be 50% in each of the Theory and practical papers separately except in English.
- III. The student has to pass in all **mandatory modules** placed within courses and the pass mark for each module is 50% (C grade). The allotted percentage of marks will be included in the internal assessment of College/ University Examination.
- IV. A candidate has to pass in theory and practical exam separately in each of the paper.
- V. If a candidate fails in either theory or practical, he/she has to re-appear for both the papers (Theory and Practical).
- VI. If the student has failed in only one subject and has passed in all other subjects of a particular semester and Grace marks of up to 5 marks to theory marks can be added for one course/subject only, provided that by such an addition the student passess the semester examination.
- VII. The candidate shall appear for exams in each semester:
  - i. The candidate shall have cleared all the previous examination before appearing for fifth semester examination. However, the candidates shall be permitted to attend the consecutive semesters.
  - ii. The candidate shall have cleared all the previous examination before appearing for seventh semester examination. However, the candidate shall be permitted to attend the consecutive semester.
  - iii. The candidate shall have cleared all the previous examination before appearing for final year examination.

The maximum period to complete the course successfully should not exceed 8 years.

VIII. The candidate has to pass separately in internal and external examination (shall be related in the marks sheet).

#### **Declaration of Pass**

First Class with Distinction - CGPA of 7.5 and above First Class - CGPA of 6.00 - 7.49 Second Class - CGPA of 5.00 - 5.99 I. A candidate for the degree of Bachelor of Science in Nursing who has completed her/his course in the minimum prescribed period and has passed each of her semester examinations at first attempt shall, at the time of graduation, be awarded the degree of Bachelor of Science in Nursing with distinction in subject/s concerned.

#### **INTERNSHIP**

- I. Every candidate shall undergo the compulsory rotatory intern-ship (integrated practice) in VIII semester in the parent institution/hospital as laid down by the Faculty of Nursing Sciences for a period of 22 weeks (1050 hours). Internship should be carried out as 8 hours per day @ 48 hours per week. Students during internship will be supervised by nursing teachers. Final examination will be held only after completing internship.
- II. On successful completion of internship as certified by Principal under whom the training was done, a candidate shall become eligible for award of B.Sc. (Nursing) degree.

#### **VACATIONS**

Student will observe vacations as under:

Winter break - 1 wk Summer break - 2 wks

Gazetted holidays - As per university calendar- 1 wk

Preparatory holidays & Examination - 2 wks

Vacation, Holidays, Preparatory and Examination Holidays: 6 weeks

#### **MIGRATION**

Migration from one Nursing College to another is not the right of a student, but in exceptional cases, University may permit the migration as per rules and regulation framed by Indian Nursing Council and University.

#### **HOSTEL**

The hostel is compulsory for all the girl students except the students whose parents are residing within local limits of Municipal Corporation, Ludhiana.

### **COLLEGE RULES FOR THE STUDENTS**

#### **COLLEGE RULES AND REGULATIONS:**

All the students are required to comply with the College Rules and Regulations:-

- Regular and punctual attendance in all class activities like lectures, demonstrations, practicals, clinical teachings, tutorials, tests etc, College activities like clinical meetings, conferences, guest lectures, seminars as well as sports, cultural activities etc. are compulsory.
- 2. As per Indian Nursing Council, New Delhi regulations, no student shall be allowed to appear in the semester examination of the concerned subject if her/his attendance falls short of 80% of the total theory teaching hours in a subject. Similarly in practicals, hospital posting and bed side clinical areas etc. attendance should not fall short of 80% of the total clinical hours. Students, whose conduct and academic standards are not considered satisfactory, shall not be allowed to appear in the university examination or to hold any office in the college or in extra-curricular organizations etc.
- Attendance at the college examinations and marks obtained in these will be taken into consideration in making the internal/academic assessment.
- 4. Leave of absence from the classes must be taken from the teachers.
- 5. Illnesses and minor ailment must be reported to the Warden/Housekeeper or class teacher as early as possible.
- 6. Students must follow Covid-19 guidelines issued by Ministry of Health and State government and must wear face mask, maintain social distance (6 feet) and wash hands with soap and water or sanitize.
- 7. The following are strictly forbidden in the institution:
  - The possession or use of alcoholic beverages or delinquency under the influence of alcohol.
  - ii. Possession or use of addictive or hallucinogenic drugs.
  - iii. Gambling.
  - iv. Possession or use of firearms or any lethal weapon.
  - v. Loitering around, especially under the influence of alcohol or other intoxicants.
  - vi. Damaging the property of college / hospital.

- 8. If any candidate found guilty he/she has to face strict disciplinary action e.g. fine/ suspension/ rustication.
- 9. Ragging of the first year students, particularly when they are admitted afresh to this college, is illegal and completely forbidden. It is punishable with fine, rustication or even expulsion from the college and also with prosecution. Ragging is defined, amongst others, as "Display of disorderly conduct, an act causing physical or psychological harm or causing apprehension of fear or shame or embarrassment." The definition also includes, "Teasing, abusing, threatening, playing practical jokes or asking a student to perform something, the student in the ordinary course, would not do". It further includes causing injury, degrading and humiliating a fellow student and causing distress of mind or spirit.
- 10. Students are not allowed to paste notices within the institution without prior written permission from the office of the Principal. They are also forbidden to communicate with any outside authority directly. All such communications must be submitted through the office of the Principal. Any student infringing this rule is liable to be suspended.
- 11. Students must pay for all damages caused by them to books and other college & Hospital property.
- 12. The college does not hold itself responsible for debts incurred by the students.
- 13. Disciplinary Action
  - i. All irregularities, neglect of duties, breach of rules and indiscipline are to be brought to the notice of the Principal. In consultation with the management, senior staff members and administrative staff shall deal with any serious offence, for which an adverse entry in the student's personal file / record register may be made and penalty imposed. Penalty could be either written or a verbal warning, fine, suspension and / or removal as an office bearer of any Organization and / or removal / expulsion from the college. The principal is competent to remit the penalty imposed by her.
  - ii. The decision of the Management in all disputes would be final and binding on the student.
- 14. In case of any dispute, civil court at Ludhiana shall alone have the jurisdiction to decide such dispute.
- 15. The provision of the prospectus can be amended on the sole discretion of the management or subject to the court order.

### **HOSTEL RULES**

Each hosteller shall be responsible for following faithfully, the following rules.

- 1. Study time has to be observed from 9.00 PM to 11.00 PM strictly, during which period students are not allowed to go to other rooms.
- 2. No student is allowed to stay alone in two or three seater rooms
- 3. No student shall keep any unauthorized person (male/female) in the room. If a hosteller is found to have a person in her room, she will be liable for disciplinary action.
- 4. No hosteller is allowed to shift furniture from one room to another.
- 5. Hostellers are responsible for cleanliness & good upkeep of rooms. Every Saturday, rooms will be inspected by faculty / Warden/Housekeeper.
- 6. Any damage to room or furniture should be reported to Warden/Housekeeper/ Floor coordinator.
- 7. No hosteller will remain absent from hostel without written permission of Warden/Housekeeper.
- 8. Every hosteller should make entry in the departure register before leaving the hostel during night pass or outing.
- 9. Hostel attendants are under control of the Warden/Housekeeper. No personnel is to be sent out for personal work without permission of the Warden/Housekeeper.
- 10. Hostellers are not allowed to keep valuables, cash or gold jewellery in the hostel. Authorities will not be responsible for any loss.
- 11. Students are not allowed to visit the rooms of the staff nurses and vice versa.
- 12. No intoxicants / alcoholic drinks are allowed in the hostel.
- 13. No one is allowed to use abusive language in hostel.
- 14. Visiting the hospital without duty or illness is not allowed.
- 15. Students are not allowed to conduct meetings/strikes in hostel. In case any student is found guilty, she will be expelled from College & Hostel.
- 16. Ragging is strictly forbidden.
- 17. All students must be present for attendance at 7.30 PM.
- 18. Electric appliances like heaters, irons, TVs, heat convectors or electric rods are NOT allowed in room. If found guilty, the concerned Hosteller will be fined Rs.500/- per item.
- 19. Rooms will be allotted by the warden. If need arises for change of room, student shall not resist for change.

- 20. All lights and fans must be switched off when leaving the room, otherwise fine of Rs. 50/- per day will be charged.
- 21. Hostel gate will be locked at 10.00 pm.
- 22. Hostellers may submit passport size photographs of three relatives and a family photograph for making identity cards so that they can visit their ward. The visitors must present the identity cards at the hostel entrance and make the necessary entry in the register kept for the purpose.
- 23. The room of any hosteller is liable to be inspected by the authorities including Senior Warden, Junior Warden and Housekeeper at any time of day or night.
- 24. Mobiles are permitted in the hostel premises only. In case any student is found with mobile phone in college / clinical area/ mess, a strict disciplinary action will be taken which can be fined Rs.500/- or expulsion from hostel. Parents are responsible for post paid cards and their records.

#### **RULES FOR VISITORS:**

- 1. No male / female visitor is allowed in the rooms.
- 2. Visiting time will be only Saturday 2.00 PM to 6.00 PM and on Sunday from 8.00 AM to 6.00 PM.
- 3. Visitors will make the entries in visitor register and will take permission from the Warden/Housekeeper to meet the student in the visitors' room only.
- 4. Only those visitors can visit, who are authorized by parents.

#### **RULES FOR SICK STUDENTS:**

- 1. Sick students must inform the Warden/Housekeeper about the need of any special diet before 9.00 am.
- Sick leave form can be obtained from the Warden/Housekeeper after explaining the sickness to the Warden/Housekeeper. Sick leave form must be submitted to class teacher after getting consultation from Dayanand Medical College & Hospital, Ludhiana. Only consultants of DMC&H will be competent to grant sick leave and no other medical certificate will be entertained.
- 3. Warden/Housekeeper will visit the rooms of sick students. If there is any problem, the students can consult Principal at any time.

#### **RULES FOR NIGHT PASS & OUTING:**

1. Two or more night passes per month are allowed on the written permission of parents only and outing will be allowed with parents undertaking only.

#### **RULES FOR PRIVATE VEHICLES**

Students carrying private vehicles (2 wheelers) must

- 1. Register their vehicle no. in the college (which they will bring to college premises). Unregistered vehicles will not be allowed to park in parking area of college.
- 2. Park their vehicle in student parking area.
- 3. Students are not allowed to bring 4 wheeler inside the campus.

#### **RULES FOR MESS:**

- 1. One month advance payment will be made by each hosteller as security to the licensee, which will be refundable at the time of leaving the institute when no dues will be made.
- 2. Mess off will be given only if a student takes consecutive fifteen or more off's with prior one day information.
- 3. Mess will be common for all hostellers under the control of the Warden/ Housekeeper.
- 4. Mess is compulsory for all hostellers.
- 5. Cooking is not allowed in hostel rooms.
- 6. All the meals should be taken in dining room at proper timings.
- 7. Room service of food is not allowed. No one is allowed to take any mess utensils outside the dining hall or to take meals in her own utensils.
- 8. While coming to mess, hostellers must be properly dressed up. Night suits and open hair are NOT allowed in the mess.
- 9. Food will be served from the serving counter. No one is allowed to enter the kitchen area.
- 10. Wastage of food, water and electricity is not allowed.
- 11. Students are not allowed to create any kind of indiscipline in mess.

#### **LIBRARY RULES FOR STUDENTS:**

- 1. The library is under the control of the library committee.
- 2. The library remains open from 8 a.m. to 6 p.m. on working days and from 9.00 am to 5.00 p.m. on Sundays and Holidays
- 3. The students shall observe the following general rules of the library:
  - i. Silence and decorum must be maintained in the library. Any infringements of this rule will result in serious disciplinary action.

- ii. Any subscriber who loses, defaces or damages a book shall be liable to pay the cost of the same, at the prevailing price. In case the book is one of a set or series, the cost of the whole set or series shall be recovered if the single copy lost/damaged is not available.
- iii. Reference books, encyclopedias, dictionaries, atlases and yearbooks shall not be issued from the library. .
- iv Books borrowed from the library are NOT transferable.
- v. Books will be issued strictly on first come first served basis.
- 4. Each student is entitled to get upto two books issued at any given time. The borrower must return the books within 14 days failing which the borrower shall be liable to pay a fine of Rs. 5/-per book for each day thereafter.
- 5. During the annual stock checking in June, all books issued must be returned. A student who does not return the books shall have to pay a fine @ Rs. 5/- per book per day.
- 6. Periodicals, publications and newspapers placed in the reading section must not be taken away under any circumstances.
- 7. Students are not allowed to use the library during class hours. They should attend classes.

#### **CLASS ROOM RULES:**

- 1. Students are not allowed to carry Mobile in the classroom.
- 2. Students who are late for more than 10 min for 3 consecutive days will be considered as one absent.
- 3. Students are required to have 80% attendance in each subject both in theory and practical before appearing in the university examination.
- 4. Night dress, bathroom slippers, open hairs are not allowed in classroom.
- 5. Students should take prior permission for absence or late coming in the class.

#### **CLINICAL AREA RULES:**

- 1. Students should be in proper uniform otherwise they will be marked absent.
- 2. Students late for more than 20 min. for 3 consecutive days during one posting will be considered as one absent.
- 3. Student having less than 80% attendance in clinical area will not be eligible for university examinations. However they have to complete 100% attendance before the award of degree.
- 4. Late submission of practical assignments will have negative marking till one week of last posting, after that no submission will be allowed.

5. Clinical attendance will be marked by finger impression (punching) or by teachers/night supervisor/ ward incharge signature in the attendance book.

#### Do's (for hospital posting)

- Carry Pocket Diary & Pocket Articles.
- Hair should be tied up neatly. Bun should be there.
- Wear Neat & Tidy, Ironed Uniform and Nails should be trimmed.
- Wear ID card and carry wrist watch.
- Leave the area only before 10 minutes of completion of duty timings.
- Strictly Adhere to duty timings.
- Break timings(one time) 15 Min (on the same floor).
- Break should be divided in between the group.
- Stay in consigned / concerned area during duty timings.
- Follow social etiquettes.
- Rules for taking leave should be followed.

#### Don'ts (for hospital posting)

- Don't Carry Mobile Phones (Hostellers).
- Day scholars must switch off mobile phones.
- Don't Carry laptop & Big Bags or luggage.
- Don't carry lunch / food items (for hostlers except night duties).
- Don't bring valuable items/gadgets/money to be hospital.
- Don't wear expensive Jewellery
- Don't sit in corridors and canteens.
- Don't leave your areas without informing teacher / ward incharge/senior staff.
- Don't take break in groups.
